Belleview School has made multiple efforts for meaningful consult with its required community members and provided for public input in the development of the plan in the following ways:

- 1. A parent committee formed and meets monthly to review data and provide input to share with the Board
- 2. Staff meets weekly to review data and make recommendations for programs, resources and expenditures for the Board to consider
- 3. Student Council meets weekly to discuss school needs, establish goals and plan actions that impact the student body

- 4. Stakeholder surveys are distributed annually to parents, students & staff to get input on school program and culture. In addition, the California Healthy Kids Survey is administered to staff, parents and students in grades 5 & 8 to determine school safety, learning and culture. All the data is reviewed by the staff, parent committee and school board to assist in the decision-making process for establishing the school plan, establish goals & actions and assign resources and plan expenditures.
- 5. The School Board meets monthly and reviews recommendations from the community, staff and students. A public forum provides opportunity for community members to ask questions and provide input.
- 6. While developing the ESSER III plan, Belleview also sought input from individuals or agencies representing the interests of Tribal Youth, Homeless and Foster Youth, youth who are low-income, youth who are incarcerated, students with disabilities, students of color, and students who are English Learners. Input was also received from community organizations and partners such as the Yes Partnership and ATCAA, the Amador-Tuolumne Community Action Agency. This outreach occurred during the time period of September 8-September 17, 2021. A survey for written responses was created and distributed during a meeting of the Student Attendance Review Board Members, which represent a number of agencies working with youth in the community, and with follow up emails as well as direct outreach to other community agencies and representatives through email and phone calls.
- 7. The Belleview School District evaluated its stakeholder engagement opportunities and determined that (Civil Rights Groups/ Migratory Students) are neither present nor served by the LEA.

A description of how the development of the plan was influenced by community input.

This year, the school community and special stakeholder interest groups expressed concern regarding the loss of learning, and need for social/emotional support, due to the pandemic and reduced instructional minutes in 2020-2021. The community input influenced the development of this plan. The development of the plan was influenced in the following ways by input received from students, families, school personnel, community organizations and representatives of student groups identified above

- 1. Re-establish a full-day schedule for in-person learning in 2021-2022 (no more hybrid model).
- 2. Provide an after school program M-F until 6pm for all grades K-8 for a maximum of 50% of the student enrollment.
- 3. Purchase supplemental online reading and math programs to provide students with additional intervention and acceleration.
- 4. Provide professional development to teachers to successfully implement the adopted curriculum and supplemental programs.
- 5. Adopt a science curriculum and provide the program and training to teachers in all grades K-8.
- 6. Pilot a math curriculum and provide training to teachers in grades K-5
- 7. Hire additional instructional aides and an intervention teacher to provide students with 1:1 and small group instruction for intervention and to accelerate learning.
- 8. Provide students with social/emotional support through the assigned District Psychologist, online programming and community outreach.
- 9. Fund a Foster Youth/Homeless Liaison who will work closely with children and families to provide them with community resources.
- 10. Maintain a safe and healthy school environment that encourages social distancing and appropriate hygiene (ie: outdoor dining, classroom furniture, hand sanitizing stations, creative scheduling to reduce group size)

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption.
