Acceptable Use Policy for the Internet

The student, in whose name an online services account is issued, is responsible for its proper use at all times. Failure to adhere to the policy and guidelines for the use of the Internet will result in the revocation of access privileges.

Student's shall use the district's system responsibly and primarily for educational purposes. Students shall report any security problem or misuse of services to the teacher or principal.

Unacceptable use of the Internet includes but is not limited to:

- Students shall not access, post, submit, publish or display harmful or inappropriate matter that is
 threatening, obscene, disruptive or sexually explicit, or that could be construed as harassment,
 or disparagement of others based on their race/ethnicity, national origin, sex, gender, sexual
 orientation, age disability, religion or political beliefs.
- Students shall not use the system to threaten, intimidate, harass, or ridicule other students or staff, such as bullying, including cyberbullying, hazing or initiation activity, extortion, or any other verbal or written conduct that causes or threatens to cause bodily harm or emotional suffering.
- Students shall not disclose, use or disseminate personal identification information about themselves or others when using email or other forms of direct electronic communication. Students are also cautioned not to disclose such information by other means to individuals located through the Internet without the permission of their parents/guardians.
- Students shall not use the system to engage in commercial or other for-profit activities.
- Students shall not use the system to encourage the use of drugs, alcohol or tobacco, nor shall they promote unethical practices or any activity prohibited by law or Board policy.
- Copyrighted material shall not be placed on the system without the author's permission. Users may download copyrighted material for their own use only.
- Students shall not intentionally upload, download or create computer viruses and/or maliciously attempt to harm or destroy district equipment or materials or manipulate the data of any other user, including "hacking."
- Students shall not attempt to interfere with other users' ability to send or receive email, nor shall they attempt to read, delete, copy, modify or use another individual's identity.
- Students are not to use the computers in the absence of a staff member of the Belleview School District.

All District computers with Internet access have a technology protection measure that blocks or filters access to material that is considered obscene, offensive or harmful to minors. Even with this filtering program, the Belleview School District cannot control the content of information available on the Internet and some of the information available is controversial and may be offensive. The Belleview School District does not condone the use of such materials.
