7.1 Superintendent-Principal's Report - (Carmel Portillo)

Campus highlights: We had our first Bike Day of the year, and it went great. Hopeful to see more participation from middle school students next time. The Harvest Carnival was a huge success. Over 130/167 students and their families attended, over \$1800 raised. A big thank you to our Parents' Club for all their organization and preparations. Red Ribbon Week was full of exciting

activities, included dress up days, 7th Grade students attended the Drugstore Project field trip, and we had a visit from Tricia Dunlap and Kia Barrieau from TCSOS with an information table about healthy choices; The Student Council put on a great Eagle Rally on Halloween Day after our school costume parade; Sports Recognition to the girls basketball team for an incredible season, cross country team, and wrestling is underway. We will be posting for a boys basketball coach. 3rd Graders took a field trip to the MiWuk Tribe, K & 1st grade visited Covers and the County Library, Turkey Trot is coming up, volunteers needed, must be cleared. Our Thanksgiving Feast is coming up, with about 75 parents who have RSVPd; Congratulations to our cafeteria staff who completed and passed it's annual and intensive Audit Review, a big thank you to Elizabeth, Lisa and Jessica for all their diligent work.

A parent asked if there were any concerning comments made prior to the letter - Carrie stated that she has been sitting next to him for years and has not heard these.

Parents asked if they will get a notification if he is released - Carmel said law enforcement will notify her of any changes and will provide a presence if necessary on campus.

Request from a parent to have text to notify that there has been an email sent to parents, Carmel explained that his detainment was confidential until public documents were filed naming his detainment. If we felt that there was any threat, we would have called school off that day. A parent asked for clarification on the timeline of information and events, Carmel provided and clarified the allowable time to inform appropriately.

Parent asked about safety plans in place moving forward. Carmel provided a brief overview of the school's safety practices.
